The Schmedding Farm

Ray Schmedding and his older brother, Maurice, bought farmland north and west of Mount Vernon, IA in 1971. The two brothers farmed together until Maurice's death in March of 1990. Ray continued to farm until his retirement.

Ray lived a very quiet, humble, and simple life. He was generous with his participation in parish life and worship. Ray was also a generous financial supporter of the parish. Having no family of his own, Ray always believed that the people of St. John were his family.

Just prior to his death in 2011, Ray gave approximately 200 acres of his farm to St. John the Baptist parish.

Under the guidance of the Archdiocese, the pastoral and financial counsels retained the land for the long-term financial benefit of the parish.

The yearly harvest from the land provides St. John with approximately, \$50,000 per year in revenue. The parish pays the property taxes and is responsible for any updates on the farm. We lease the land to a local farmer who provides the work of planting, cultivating and harvesting.

Ray's generous gift continues to help St. John be a strong and vibrant presence in the Lisbon and Mount Vernon area. His gift provides us all with an extraordinary example of authentic *Stewardship*.
